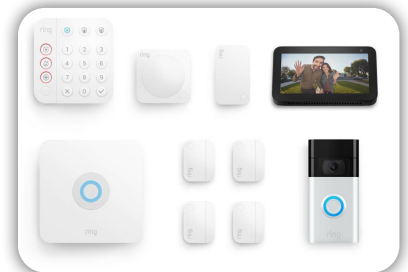

IS YOUR CD ABOUT TO MATURE?
