## Indiana Members Credit Union Indy Eleven Fan Appreciation Sweepstakes Official Rules

Official Rules – Indiana Members Credit Union "IMCU Indy Eleven Fan Appreciation Sweepstakes" October 15, 2024 – October 17, 2024.

NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.

- 1. ELIGIBILITY: The Indiana Members Credit Union "IMCU Indy Eleven Fan Appreciation Sweepstakes" is offered and open only to legal residents who reside in Indiana Members Credit Union's service territory: Bartholomew, Blackford, Boone, Brown, Clark, Clay, Clinton, Decatur, Delaware, Floyd, Fountain, Gibson, Grant, Greene, Hamilton, Hancock, Harrison, Hendricks, Henry, Howard, Huntington, Jackson, Jay, Jefferson, Jennings, Johnson, Lawrence, Madison, Marion, Miami, Monroe, Montgomery, Morgan, Owen, Parke, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Tippecanoe, Tipton, Vanderburgh, Vigo, Warrick, and Wayne counties in Indiana, and Henderson County in Kentucky and who are at least 18 (eighteen) years old at the time of entry (each an "Entrant" and collectively the "Entrants"). By entering, you agree to follow these Indiana Members Credit Union "IMCU Indy Eleven Fan Appreciation Sweepstakes" official rules (the "Official Rules"). No fee is required for entry. VOID WHERE PROHIBITED. Employees and, family members (spouse, parents, siblings, and children) or individuals living in the same household as employees of Indiana Members Credit Union ("Sponsor"), Indy Eleven Employees and Team Members and each of their respective parents, subsidiaries, affiliates, directors, contractors, vendors, marketing and promotion agencies, officers, owners, members, employees and agents are not eligible to participate in this "IMCU **Indy Eleven Fan Appreciation Sweepstakes**".
- 2. SWEEPSTAKES PERIOD: The Sweepstakes Period begins on Tuesday, October 15, 2024, at 12:00 p.m. Eastern Time, and ends on Thursday, October 17, 2024 at 12:00 p.m. Eastern Time (the "Sweepstakes Period").
- 3. HOW TO ACCESS AND ENTER: The first day of the Sweepstakes Period, Sponsor will post a "IMCU Indy Eleven Fan Appreciation Sweepstakes" question on its IMCU Facebook, X (Formerly Twitter) and Instagram pages. There are three ways to enter during the Sweepstakes Period:

VIA FACEBOOK: To enter via Facebook, (i) visit the IMCU Facebook page and respond with the correct answer to the IMCU post containing "IMCU Indy Eleven Fan Appreciation Sweepstakes" via a comment on the post. Entrant must have a Facebook account to participate in and enter this Sweepstakes via Facebook. Entrant must have a non-private X (Formerly Twitter) account to participate in and enter this Sweepstakes via X (Formerly Twitter). If an Entrant does not have a non-private account, there is no cost to create one at <a href="https://x.com/en/tos">www.x.com</a>. Entrant must agree to comply with the X (Formerly Twitter) Terms of Service (<a href="https://x.com/en/tos">https://x.com/en/tos</a>) and X (Formerly Twitter) Privacy Policy (<a href="https://x.com/en/privacy">https://x.com/en/privacy</a>) in order to create an X (Formerly Twitter) account.

VIA INSTAGRAM: To enter via Instagram: (i) Follow @IndMembersCU on Instagram by going to <a href="https://www.instagram.com/indmemberscu/">https://www.instagram.com/indmemberscu/</a> and clicking the "follow" button; and (ii) comment with the correct answer to the IMCU post containing "Indy Eleven Fan Appreciation Sweepstakes" question using the hashtag #IMCUIndyElevenFanAppreciationSweepstakes. Entrant must have a non-private Instagram account to participate in and enter this Sweepstakes via Instagram. If an Entrant does not have a non-private account, there is no cost to create one at <a href="https://www.instagram.com/">https://www.instagram.com/</a>. Limit one entry per person, per social platform, regardless of entry method used. Multiple entries per person, including multiple entries by the same Entrant using different e-mail addresses, will invalidate ALL entries submitted by that Entrant for the entire Entry Period. Entrants must respond with the correct answer to the question posted by Sponsor to be eligible to win. All entries must be received by Sponsor by Thursday, October 17, 2024 at 12:00 p.m. Eastern Time. Due to the way Facebook, X (Formerly Twitter) and Instagram operates their services, Sponsor may not receive entries from Facebook X (Formerly Twitter) and Instagram with "protected" updates or profiles. For Entrants entering on X (Formerly Twitter) and Instagram, Entrants must continue to follow @IndMembersCU on X (Formerly Twitter) and Instagram through the Sweepstakes Period and for at least thirty (30) days thereafter (for potential notification purposes) to participate in the Sweepstakes and be eligible to win. For Entrants entering on Facebook, Entrants must continue to maintain an active Facebook account through the Sweepstakes Period and for at least thirty (30) days thereafter (for potential notification purposes) to participate in the Sweepstakes and be eligible to win.

All X (Formerly Twitter), Instagram, and Facebook posts must NOT, in the sole discretion of Sponsor, (i) contain language that violates or infringes upon another's rights, including but not limited to privacy, publicity or intellectual property rights (including, without limitation, trademark or copyright infringement); (ii) contain language that is inappropriate, indecent, obscene, profane, hateful, tortious, defamatory, slanderous, controversial or libelous; (iii) contain

- 4. DRAWING/ODDS: Sponsor will hold a random drawing from the pool of eligible entries. Entrants must answer the question correctly to be eligible to be selected as a winner. The drawing will be held on Thursday, October 17, 2024, at 12:30 p.m. Eastern Time. Odds of winning will depend on the number of eligible entries received. In the event of a dispute as to the identity of a winner, the Sponsor's decision will be final. Winner will be notified within twenty-four (24) hours of winning via the platform on which they submitted their entry (Facebook, X (Formerly Twitter), Instagram). Winner will be required to respond (as directed) within twenty-four (24) hours of an attempted notification prior to being awarded a prize. Failure to respond to the notification within this timeframe may result in forfeiture of the prize. Sponsor, in its sole discretion, may attempt to contact up to three (3) potential winners of a prize with the above procedure after which the prize in question may go un-awarded if it remains unclaimed.

The total value of all prizes combined is \$570.

Sponsor reserves the right to substitute any prize with any alternate prize of equal or greater value at its discretion. Indy Eleven Zip Up Fleece Jacket, Indy Eleven Scarf, and Indy Eleven Tickets for the October 19<sup>th</sup>, 2024 Match are not redeemable for cash. Limit one prize per winner throughout the Sweepstakes Period.

The prize must be picked up at Indiana Members Credit Union's Southside Branch, 5047 Madison Ave., Indianapolis, IN 46227, by 4:00 pm on Friday, October 18, 2024 or it will be forfeited.

Sponsor is not responsible for lost, stolen, damaged, mutilated, returned, "bounced back" emails or misdirected mail, or unsafe arrival of a prize.

If the prize notification is returned as non-deliverable, or if winner is found to be ineligible or not to be in compliance with these Official Rules, winner may be disqualified and an alternate winner will be selected.

The prize winner is solely responsible for all applicable federal, state and local taxes and any expenses associated with the Sweepstakes, unless otherwise indicated.

6.
