

Indiana Members Credit Union 2024 Old Meridian Branch Open House Sweepstakes Rules

Official Rules – Indiana Members Credit Union “IMCU 2024 Old Meridian Branch Open House Sweepstakes” Friday, August 30, 2024 – Saturday, August 31, 2024.

NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.

1. **ELIGIBILITY:** The Indiana Members Credit Union “**IMCU Old Meridian Branch Open House Sweepstakes**” is offered and open only to legal residents who work or reside in Indiana Members Credit Union’s service territory: Bartholomew, Blackford, Boone, Brown, Clark, Clay, Clinton, Decatur, Delaware, Floyd, Fountain, Gibson, Grant, Greene, Hamilton, Hancock, Harris, Hendricks, Henry, Howard, Huntington, Jackson, Jay, Jefferson, Jennings, Johnson, Lawrence, Madison, Marion, Miami, Monroe, Montgomery, Morgan, Owen, Parke, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Tippecanoe, Tipton, Vanderburgh, Vigo, Warrick, and Wayne counties in Indiana, and Henderson County in Kentucky and who are at least 18 (eighteen) years old at the time of entry (“Entrants”). By entering, you agree to follow these Indiana Members Credit Union “**IMCU Old Meridian Branch Open House Sweepstakes**” official rules (the "Official Rules"). No fee is required for entry. **VOID WHERE PROHIBITED.** Employees, directors, contractors, vendors, marketing and promotion agencies, family members or individuals living in the same household as employees of Indiana Members Credit Union (“Sponsor”) are not eligible to participate.

2. **SWEEPSTAKES PERIOD:** The Sweepstakes Period begins on Friday, August 30, 2024 at 12:01 a.m. Eastern Time, and ends on Saturday, August 31, 2024 at 11:59 p.m. Eastern Time (the Sweepstakes Period”).

3. **HOW TO ACCESS AND ENTER:** (1) Fill out the enter to win slip at the Old Meridian Branch. (2) OR mail a 4" x 6" card with the following information: your full name; your complete address; Valid email address (if you do not have an email address, print "no email address"); Valid telephone number; the words “IMCU Old Meridian Branch Open House Sweepstakes”; and your signature.

Limit one entry per person, regardless of entry method used.

4. **DRAWING/ODDS:** Sponsor will hold a random drawing from the pool of eligible entries. The drawings will be held on Friday, August 30 and Saturday, August 31, 2024. Odds of winning will depend on the number of eligible entries received. In the event of a dispute as to the identity of a winner, the Sponsor’s decision will be final. Winners will be notified via phone or email, on record for their account.

5. PRIZES: Two (2) winners will be selected in random drawings. Nine (9) Prizes including (4) Indianapolis Zoo Tickets valued at \$34.75 per ticket, one (1) Indianapolis Zoo Parking Pass valued at \$10, two (2) Indiana Fever tickets, valued at \$82.50 per ticket, and two (2) Indiana Fever hats, valued at \$35 per hat, will be awarded. The total value of all prizes combined is \$384.00.

Sponsor reserves the right to substitute any prize with any alternate prize of equal or greater value at its discretion. Gift cards are not redeemable for cash. Limit one prize per winner throughout the Sweepstakes Period.

The prize must be picked up at the Indiana Members Credit Union Old Meridian Branch, located at 12725 Old Meridian St., Carmel, Indiana by 5:00 pm EST on Friday, September 4, 2024 or they will be forfeited.

Sponsor is not responsible for lost, stolen, damaged, mutilated, returned, “bounced back” emails, or misdirected mail, or unsafe arrival of a prize.

If the prize notification is returned as non-deliverable, or if winner is found to be ineligible or not to be in compliance with these Official Rules, winner may be disqualified and an alternate winner will be selected.

The prize winner is solely responsible for all applicable federal, state and local taxes and any expenses associated with the Sweepstakes, unless otherwise indicated.

6. GENERAL CONDITIONS: By entering in the Sweepstakes, unless you opt out, you authorize Sponsor to use, without further notification to you, review or approval by you, your name if you become a winner, to publicize the Sweepstakes and inform other Entrants of your winning. Each entry submission must be manually key stroked and manually entered by the individual Entrant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or Sweepstakes service) will be disqualified and transmissions from these or related email or IP addresses may be blocked. The accumulation of entries generated through robotic, automatic, macro, or like methods is also strictly prohibited.

If, for any reason, Sponsor is unable to run this Sweepstakes as planned due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which, in the sole opinion of Sponsor, corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, Sponsor reserves the right to cancel, terminate, modify or suspend the Sweepstakes. If the Sweepstakes is terminated due to tampering or technical difficulties prior to its expiration date, notice will be posted at Indiana Members Credit Union's Facebook page and on X (formerly Twitter) and Instagram.
