

Indiana Members Credit Union 2024 Light Up the Night Sweepstakes Rules

Official Rules – Indiana Members Credit Union “IMCU 2024 Light Up the Night Sweepstakes” Friday, November 29, 2024 – Friday, November 29, 2024.

NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.

1. **ELIGIBILITY:** The Indiana Members Credit Union “**IMCU 2024 Light Up the Night Sweepstakes**” is offered and open only to legal residents who work or reside in Indiana Members Credit Union’s service territory: Bartholomew, Blackford, Boone, Brown, Clark, Clay, Clinton, Decatur, Delaware, Floyd, Fountain, Gibson, Grant, Greene, Hamilton, Hancock, Harris, Hendricks, Henry, Howard, Huntington, Jackson, Jay, Jefferson, Jennings, Johnson, Lawrence, Madison, Marion, Miami, Monroe, Montgomery, Morgan, Owen, Parke, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Tippecanoe, Tipton, Vanderburgh, Vigo, Warrick, and Wayne counties in Indiana, and Henderson County in Kentucky and who are at least 18 (eighteen) years old at the time of entry (“Entrants”). By entering, you agree to follow these Indiana Members Credit Union “**IMCU 2024 Light Up the Night Sweepstakes**” official rules (the "Official Rules"). No fee is required for entry. **VOID WHERE PROHIBITED.** Employees, directors, contractors, vendors, marketing and promotion agencies, family members or individuals living in the same household as employees of Indiana Members Credit Union (“Sponsor”) are not eligible to participate.

2. **SWEEPSTAKES PERIOD:** The Sweepstakes Period begins on Friday, November 29, 2024 at 5:00 p.m. Eastern Time, and ends on Friday, November 29, 2024 at 8:00 p.m. Eastern Time (the Sweepstakes Period”).

3. **HOW TO ACCESS AND ENTER:** (1) Scan the QR Code on the enter to win poster at the Downtown Branch, 50 N. Pennsylvania St., Indianapolis, IN, and fill out and submit the electronic form.

Limit one entry per person, regardless of entry method used.

4. **DRAWING/ODDS:** Sponsor will hold a random drawing from the pool of eligible entries. The drawings will be held on Monday, December 2, 2024. Odds of winning will depend on the number of eligible entries received. In the event of a dispute as to the identity of a winner, the Sponsor’s decision will be final. Winners will be notified via phone or email, on record for their account.

5. **PRIZES:** One (1) winner will be selected in random drawings. One (1) Prize including four (4) tickets to the Christmas at the Zoo presented by Indiana Members Credit Union, valued at \$87 in total will be awarded. The total value of all prizes combined is \$87.00.

Sponsor reserves the right to substitute any prize with any alternate prize of equal or greater value at its discretion. Gift cards are not redeemable for cash. Limit one prize per winner throughout the Sweepstakes Period.

The prize must be picked up at the Indiana Members Credit Union Downtown Branch, located at 50 N. Pennsylvania St., Indianapolis, Indiana by 4:00 p. m. EST on Friday, December 6, 2024 or they will be forfeited.

Sponsor is not responsible for lost, stolen, damaged, mutilated, returned, “bounced back” emails, or misdirected mail, or unsafe arrival of a prize.

If the prize notification is returned as non-deliverable, or if winner is found to be ineligible or not to be in compliance with these Official Rules, winner may be disqualified and an alternate winner will be selected.

The prize winner is solely responsible for all applicable federal, state and local taxes and any expenses associated with the Sweepstakes, unless otherwise indicated.

6. GENERAL CONDITIONS: By entering in the Sweepstakes, unless you opt out, you authorize Sponsor to use, without further notification to you, review or approval by you, your name if you become a winner, to publicize the Sweepstakes and inform other Entrants of your winning. Each entry submission must be manually key stroked and manually entered by the individual Entrant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or Sweepstakes service) will be disqualified and transmissions from these or related email or IP addresses may be blocked. The accumulation of entries generated through robotic, automatic, macro, or like methods is also strictly prohibited. Sponsor's determination of whether a user is accumulating entries generated through automated means is in Sponsor's sole discretion.
