## Indiana Members Credit Union 2024 Light Up the Night Sweepstakes Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.

- 1. ELIGIBILITY: The Indiana Members Credit Union "IMCU 2024 Light Up the Night Sweepstakes" is offered and open only to legal residents who work or reside in Indiana Members Credit Union's service territory: Bartholomew, Blackford, Boone, Brown, Clark, Clay, Clinton, Decatur, Delaware, Floyd, Fountain, Gibson, Grant, Greene, Hamilton, Hancock, Harris, Hendricks, Henry, Howard, Huntington, Jackson, Jay, Jefferson, Jennings, Johnson, Lawrence, Madison, Marion, Miami, Monroe, Montgomery, Morgan, Owen, Parke, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Tippecanoe, Tipton, Vanderburgh, Vigo, Warrick, and Wayne counties in Indiana, and Henderson County in Kentucky and who are at least 18 (eighteen) years old at the time of entry ("Entrants"). Limit one entry per person, regardless of entry method used.

- 4. DRAWING/ODDS: Sponsor will hold a random drawing from the pool of eligible entries. The drawings will be held on Monday, December 2, 2024. Odds of winning will depend on the number of eligible entries received. In the event of a dispute as to the identity of a winner, the Sponsor's decision will be final. Winners will be notified via phone or email, on record for their account.

The prize must be picked up at the Indiana Members Credit Union Downtown Branch, located at 50 N. Pennsylvania St., Indianapolis, Indiana by 4:00 p. m. EST on Friday, December 6, 2024 or they will be forfeited.

Sponsor is not responsible for lost, stolen, damaged, mutilated, returned, "bounced back" emails, or misdirected mail, or unsafe arrival of a prize.

If the prize notification is returned as non-deliverable, or if winner is found to be ineligible or not to be in compliance with these Official Rules, winner may be disqualified and an alternate winner will be selected.
