Indiana Members Credit Union Back to School Sweepstakes Rules

Official Rules – Indiana Members Credit Union "IMCU Back to School Sweepstakes" August 1, 2023 – August 31, 2023.

NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.

1. ELIGIBILITY: The Indiana Members Credit Union "IMCU Back to School Sweepstakes" is offered and open only to legal residents who work or reside in Indiana Members Credit Union's service territory: Bartholomew, Blackford, Boone, Brown, Clark, Clay, Clinton, Decatur, Delaware, Floyd, Fountain, Gibson, Grant, Hamilton, Hancock, Hendricks, Henry, Howard, Huntington, Jackson, Jefferson, Jennings, Johnson, Madison, Marion, Miami, Monroe, Montgomery, Morgan, Owen, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Tippecanoe, Tipton, Vanderburgh, Vigo and Warrick counties in Indiana, and Henderson County in Kentucky and who are at least 18 (eighteen) years old at the time of entry ("Entrants"). By entering, you agree to follow these Indiana Members Credit Union "IMCU Back to School Sweepstakes" official rules (the "Official Rules"). No fee is required for entry. VOID WHERE PROHIBITED. Employees, directors, contractors, vendors, marketing and promotion agencies, family members or individuals living in the same household as employees of Indiana Members Credit Union ("Sponsor") are not eligible to participate.

2. CONTEST PERIOD: The Sweepstakes Period begins on Tuesday, August 1, 2023, at 12:00 a.m. Eastern Time, and ends on Thursday, August 31, 2023 at 11:59 p.m. Eastern Time (the "Sweepstakes Period").

3. HOW TO ACCESS AND ENTER: Using the SmartStart Platform available in the IMCU App, earn a trophy for each completed action (create a budget, save money, chores completed, good grades). Entries will also be accepted at https://www.imcu.com/register-to-win. All entries will be combined and winners will be drawn at random from the pool of entries.

4. DRAWING/ODDS: Sponsor will hold a random drawing from the pool of eligible entries. The drawing will take place on Friday, September 1, 2023. Odds of winning will depend on the number of eligible entries received. In the event of a dispute as to the identity of a winner, the Sponsor's decision will be final. Winner will be required to respond (as directed) within twenty-four (24) hours of an attempted notification prior to being awarded a prize. Failure to respond to the notification within this timeframe may result in forfeiture of the prize. Sponsor, in its sole discretion, may attempt to contact up to three (3) potential winners of a prize with the above procedure after which the prize in question may go un-awarded if it remains unclaimed.

Sponsor reserves the right to substitute any prize with any alternate prize of equal or greater value at its discretion. Gift Cards are not redeemable for cash. Limit one prize per winner throughout the Sweepstakes Period.

All prizes must be picked up at Indiana Members Credit Union's Southside Branch, 5047 Madison Ave., Indianapolis, IN 46227, by 1:00 pm on Saturday, May 6, 2023 or it will be forfeited.

Sponsor is not responsible for lost, stolen, damaged, mutilated, returned, "bounced back" emails or misdirected mail, or unsafe arrival of a prize.

If the prize notification is returned as non-deliverable, or if winner is found to be ineligible or not to be in compliance with these Official Rules, winner may be disqualified and an alternate winner will be selected.

The prize winner is solely responsible for all applicable federal, state and local taxes and any expenses associated with the Sweepstakes, unless otherwise indicated.
